Subject: Consolidated Scrutinizer's Report on Remote E-voting conducted for the 03rd Annual General Meeting of Healthy Life Agritec Limited held on 28th September, 2022 at 03.00 P.M. (IST) through video conferencing ('VC') / other audio visual means ('OAVM').

Dear Sir,

I, Vivek Rawal, Partner of Vikas Verma & Associates, Company Secretaries in Practice having office at B-502, Statesman House, 148, Barakhamba Road, New Delhi -110001 were appointed as a Scrutinizer by the Board of Directors of Healthy Life Agritec Limited ("the Company") pursuant to Section 108 of the Companies Ac, 2013 ("the Act") read with Rules 20 of the Companies (Management & Administration) rules 2014 as amended by Companies (Management & Administration) Amendment Rules, 2015 for the purpose of scrutinizing the remote e-voting, on the below mentioned resolutions contained in the Notice of O3rd Annual General Meeting of Healthy Life Agritec Limited held on Wednesday, 28th September, 2022 at 03:00 P.M. (IST) through Video Conferencing ("VC")/Other Audio-Visual means.

The compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to voting through electronic means and voting by poll by the Shareholders on the resolutions proposed in the Notice of 03rd Annual General Meeting of the Company is the responsibility of management. My responsibility as a scrutinizer is to ensure that the voting process, through electronic means are conducted in a fair and transparent manner and to render consolidated scrutinizer's report of the total votes cast "in favour or against", if any, to the Chairman on the resolutions, based on the reports generated from the electronic voting system.

I, submit my report as under:

- 1. In terms of Section 108 and Section 110 of Companies Act, 2013 read with rules and SEBI Listing Regulations, 2015, the Company had made arrangement with Central Depository Services (India) Limited ("CDSL") for providing facility of voting through electronic means ("Remote e-voting") to its members.
- 2. As per Rule 22 (3) Companies (Management & Administration) Rules, 2014 the Company published an advertisement on <u>September 09, 2022</u> about the dispatch of Notice in "Active Times" (English) and "Mumbai Lakshadeep" (Marathi).
- 3. The voting period for remote e-voting commenced on <u>Sunday, September 25, 2022 (9:00 A.M. IST)</u> and ended on <u>Tuesday, September 27, 2022 (5:00 P.M. IST)</u> and the CDSL e-voting platform was disabled thereafter.
- 4. The Company had also provided remote e-voting facility to the shareholders present at the AGM through VC/OAVM and who had not cast their vote earlier.
- 5. The shareholders of the Company holding shares as on the "cut-off" date <u>Wednesday</u>, <u>September 21, 2022</u> were entitled to vote on the resolutions as contained in the Notice of the AGM.
- 6. After the closure of voting at the AGM, the report on the voting done during the AGM and the votes cast under remote e-voting facility prior to the AGM were unblocked and counted.
- 7. We, have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the Central Depository Services India Limited ("CDSL") e-voting system. After the time fixed for closing of the e-voting i.e., 5:00 P.M. on September 27, 2022, and venue voting after AGM, an electronic report of the e-voting was generated by me by accessing the data available from the website https://www.evotingindia.com/ of CDSL. Based on such reports generated by CDSL and relied upon by me, data regarding the e-votes was scrutinized on test check basis.
- 8. I would like to mention that the voting rights of Members were in proportion to their share of the paid-up equity share capital of the Company as on the cut-off date i.e. **Wednesday**, **September 21**, **2022** and as per the Register of Members of the Company.
- 9. The particulars of Voting and other requisite details have been entered in a separate register maintained for the purpose.
